[15] Description of Product

The covered equipment, headsets and ear plug are intended to be used for radio communication. Connection may be direct to radio units or may go via PTT (Push-To-Talk) units. The offshore ear plug may be used as stand-alone unit to be connected to PTT units, or as accessory to the headset models AK5850S/-HS/-BHS/-BS. However, certificates of radios or PTT units must allow intrinsic safe connections with the covered equipment. In other words matching of safety parameters is important for intrinsic safe connection in the end use. The below simplified comparison conditions may be used.
